Rock the Bike is renting the above items to the above named for use at the above listed event. Rock the Bike represents and warrants that the rental equipment is in good repair and good operating condition, and fit for its intended use and purpose. The Renter, by accepting these items and signing this form, agrees to the following conditions:

1. Payment in full and a Credit Card Authorization Form are required to reserve rental gear, prior to shipping or pick-up dates. This contract becomes void if payment and/or the Authorization Form is not received.
2. We reserve the right to request a security deposit on a credit card or in cash, up to the value of the rental gear.
3. The renter assumes full responsibility for safe return of all Rock the Bike products, in original condition less normal wear and tear, by or before the given return date as listed on the Invoice.
4. A Rock the Bike Crew member must check in all returns. Do not leave returns at the workshop without contacting a Rock the Bike Crew member.

_____(Initial) 5. Renter is responsible for dropping off rental bike at a FedEx location or scheduling a FedEx pick-up the day before your ship back date listed on the invoice. The return label is provided by RTB and must be placed on the outside of the box. A \$100 fee will be charged per day for late returns.

6. Alterations to rental items are strictly prohibited. If you are having installation or performance troubles, call our workshop for assistance: 1-888-354-2453. Any alteration may be viewed as damage, and repair charges will be assessed. Rock the Bike is not liable for any damages that arise from improper assembly and/or unsafe operation of equipment as set forth by Rock the Bike representatives and/or official manuals. Please call 1-888-354-2453, as soon as possible to receive help from our Tech Support team, Monday through Friday, 9:30 AM to 5:30 PM, PST.

_____(Initial) 7. Rentals to begin upon receipt of equipment by Renter, and shall continue until same is returned to Rock the Bike. The Renter agrees to pay for any damages to the equipment, beyond reasonable wear and tear, while in their possession. In the event of damage or loss, the Renter will pay either the replacement value of the product or a repair charge.

8. Rental rates include one day for receiving, and one day for return. Out-of-town renters will be charged a packaging fee and the cost of shipping, and may be granted an additional day for receiving, up to two days before their event date.

9. All rental blenders, spin art, or ice cream parts must be returned clean and re-assembled. A \$25 per item cleaning fee will be assessed for any equipment not returned in clean condition.

10. Rock the Bike will refund the cost of rental items that did not meet the rental standards set forth by Rock the Bike representatives and or official manuals. If a defect is found, it is the renter's responsibility to notify Rock the Bike, as soon as possible. Please call 1-888-354-2453 to receive help from our Tech Support team, Monday through Friday, 9:30 AM to 5:30 PM, PST.

11. Rock the Bike ensures items are shipped on time for an on-time delivery. **Rock the Bike is not responsible for Third Party/ courier shipping delays**, or for the loss it may cause to your organization, brand, or event. Credits of rental fees will be handled on a case-by-case basis if your rental delivery is late due to inclement weather, acts of God, other unforeseeable delays, ore negligence by Third Party couriers. Renter should notify Rock the Bike as soon as possible to correct any Third Party or courier delays. Additionally, if your event is cancelled due to weather we will not reimburse your rental.

_____(Initial) 12. If you need to cancel, we will retain 25% of your rental amount and refund 75% of your rental cost. Cancellations must be made 2 weeks prior to your shipping date, which is listed on your Estimate or Invoice.

_____(Initial) 13. Renter is responsible for the safe operation of rented Rock the Bike gear and equipment while in renter's possession. Rock The Bike is not responsible for any third party claims that arise from use not prescribed by Rock the Bike as set forth by user manuals, assembly manuals or guidance of a Rock the Bike representative.

_____(Initial) 14. Failure to comply with the conditions listed will result in additional charges.
